Unanimously carried to approve the minutes from the October 17, 2023 Regular City Council meeting.

City Auditor Rob Carter presented the audit report for the 2022-2023 fiscal year.

Approve the utility payment contract with Tyler Technology, which would require the City of Kaplan to implement a \$3.00 technology fee on all bills commencing on the April 2024 billing cycle. This contract would give us the opportunity to collect permit fees and property taxes via credit card in the near future.
